

UCT's Accidental Death and Hospital Indemnity Plan – ADHIP for short – is a plan of protection for people on the move, like you. It's a plan that gives 24-hour-a-day coverage in case of accidents, whether you're at home, at work, at play or traveling. ADHIP will cover you no matter where you are in the world.

## **ADHIP Features**

- Emergency medical treatment benefit. In addition to your accident and hospital indemnity benefits, you may be reimbursed up to \$50 per accident for emergency medical treatment within 24 hours of a covered accident.
- Guaranteed issue.

All applicants ages 18 through 70\*, their spouses and dependent children up to age 18 are eligible for coverage. There are no medical exams required and you can't be turned down due to health.

- No deductibles.
- Benefits are paid directly to you, no matter what other coverage you may have.

In fact, ADHIP can help fill the costly gaps in your regular health coverage or help you meet deductibles and co-payments.

### **Exceptions/Limitations**

ADHIP will not pay benefits for death or hospital confinement due to the following: any act of war, declared or undeclared, or any act incident to war or military service; intentionally selfinflicted injury or suicide; hernia; any infection, except an infection resulting from an open wound that was caused by accidental bodily injury and is visible to the unaided eye; air travel as a pilot or crew member; injuries relieved while racing or testing any vehicle on speedways, racetracks or proving grounds; mental, nervous or emotional disorders; injuries received while intoxicated, or while under the influence of a narcotic, unless prescribed by a physician; or injuries received while committing or attempting to commit a felony or being engaged in an illegal occupation.

Death benefits are not provided for death which occurs more than 90 days after the accident.
